Our consumer media tour, which focused on what to expect when starting chemotherapy, reached **10.3 million listeners**....



.....resulting in **64,281 people downloading** our free medication tracking list, enabling them to record vital information about their medications (what, dose, frequency, when to take) and to easily share that information with medical professionals and caregivers.



More than **\$228,400 was awarded** to pharmacist researchers conducting practice-based research that will result in helping patients get well and stay well.



More than **1,600 pharmacists used** the Antithrombotic-Use Assessment Tool to promote the safe and effective use of antithrombotic medications in their inpatient hospital and ambulatory settings.



More than **260 pharmacists participated** in our patient care traineeships, enabling them to improve patient care in the areas of critical care, oncology and pain and palliative care in their hospitals and health systems.



More than **11,000 pharmacists downloaded** the free Pharmacy Forecast report, which assisted them in strategic planning for their pharmacy departments and enabling them to continue to offer the best care possible.



**Another class of pharmacists completed** the Pharmacy Leadership Academy, bringing the total of pharmacists who are prepared to step into high-level leadership positions in their health systems to 561. Pharmacist leaders heavily influence best practices in medication safety and other important areas of patient care.

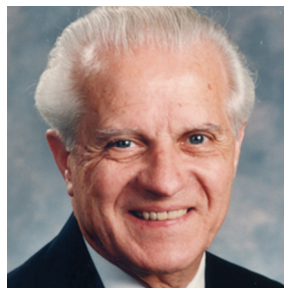

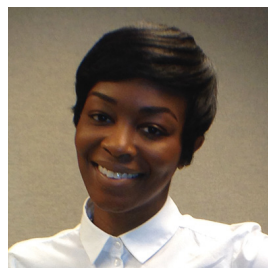
**MEAGHAN L. CUNNINGHAM,

The Award for Excellence in Medication-Use Safety is the only awards program to honor a pharmacist-led interprofessional team that makes significant institution-wide system improvements in medication-use safety and quality. It recognizes on a national level pharmacists who have assumed a leadership role in transforming the medication-use process in their institutions that led to improved patient outcomes. The recipient receives a \$50,000 award, while two finalists each receive a \$10,000 award.

To assist with building appreciation for near-term, impactful changes in pharmacy practice, the University of Minnesota College of Pharmacy created bi-annual “PED-Rx” (Practice-Education Dialogue in Pharmacy) events. Each of these half-day events focuses on a theme rooted in a contemporary issue that will likely evolve considerably between now and the students’ first few years in practice.

“PED-Rx takes its cues from the TED/ TEDx model, combining short, engaging

TED-like presentations with structured discussions between student pharmacists and local practitioners.

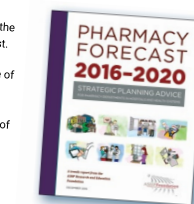
## Change Is the Only Constant

Five-year Pharmacy Forecast:

New Orleans—From pipeline to patient, the practice of health-system pharmacy is set to change over the next five years, according to the ASHP Foundation's annual Pharmacy Forecast.

Nearly 135 pharmacy experts opined on some of the most significant trends in the profession, such as increased collaboration between outpatient and inpatient pharmacies, the addition of more clinical responsibilities for health-system pharmacists and a shift toward use of new oral anticoagulants as some forces that will shape practice in the next five years.

“The number of issues and the diversity, complexity and activities around them that have to be dealt with are accelerating at an algorithmic rate,” David Zitz, MS, a clinical professor emeritus and the former director of pharmacy at the University of Wisconsin Hospital and Clinics in Iowa, told attendees of a

Whitney Award Lectures Online Collection raises awareness of the Whitney Award, an award established to honor a visionary and outstanding leader in hospital pharmacy who served as the first ASHP president. The Foundation hosts a website that houses the lectures given by all recipients of the Whitney Award since 1950, including 2015 recipient Sharon Murphy Enright's lecture, *"Lean Back, Listen, and Own Up."*

The site, which was redesigned in 2015 for a more modern look and to be mobile responsive, can be browsed by title, author or publication date. Each lecture has a web page that contains the awardee's biography, photograph, the lecture and a PDF version that can be downloaded; there are videotaped interviews with several recent Whitney award-ees; and the site is searchable by keyword.

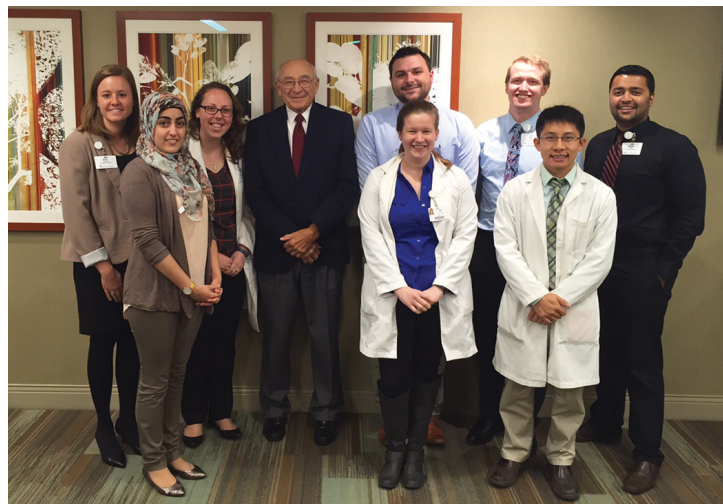

## 2015 William A. Zellmer Lecture Award

**John M. Coster, September 15, 2015**  
***“Pharmacy and Public Policy: A Roadmap for the Future”***

John M. Coster, Ph.D., R.Ph., delivered the 2015 William A. Zellmer Lecture on September 15, 2015, as part of ASHP Policy Week activities. Attendees included approximately 130 leaders in pharmacy practice. His remarks will appear in full in a future issue of the *American Journal of Health-System Pharmacy*.

Dr. Coster is Director, Division of Pharmacy, Center for Medicaid and CHIP Services, Centers for Medicare & Medicaid Services (CMS). Before that, he served as Senior Vice President of Government Affairs at the National Community Pharmacists Association; Vice President of Federal Affairs and Public Policy of Rite Aid Corp.; and Vice President, Policy & Programs, for the National Association of Chain Drug Stores. He developed extensive experience in pharmaceutical coverage from his experience as a professional staff member of the United States Senate Special Committee on Aging (1990 - 1994), including his involvement in drafting the Medicaid pharmaceutical rebate provisions of the Omnibus Budget Reconciliation Act (OBRA) of 1990 and the Veterans Health Care Act of 1992. During that time, he also served as a member of President Clinton’s Task Force on Health Care Reform. From 1984 to 1990, Dr. Coster worked as a health analyst at the United States Congress Office of Technology Assessment and a Policy Fellow at the Center on Drugs and Public Policy at the University of Maryland Graduate School in Baltimore. He began his career as an ASHP staff member. John also completed the ASHP Executive Residency Program.

The William A. Zellmer Lecture was established in 2010 by ASHP in collaboration with the ASHP Foundation to honor Zellmer’s

numerous contributions to pharmacy practice in the United States and abroad. The lecture is given annually during ASHP Policy Week by a distinguished individual who has demonstrated exceptional leadership in advancing health-care-related public policy that has improved the safety and effectiveness of medication use through the engagement of pharmacists.

# ADVANCING PRACTICE

## Pharmacy Residency Expansion Grant Program

*Supported by educational donations from Amgen, Merck & Company, Inc., BD Medical Systems, Omnicell, Inc., PharMEDium Services LLC and Samson Medical Technologies*

The [Pharmacy Residency Expansion Grant Program](#) made it possible for the ASHP Foundation to award \$400,000 in grants to 10 institutions for use in establishing additional pharmacy residency positions. Now in its fifth year, the program has provided seed funding to expand available residency positions. In 2015, 1,870 residency programs in the United States offered 3,987 positions, an increase of 9.1 percent from 2014.

Residency training is critical to new pharmacists, who are going into a health-care environment that increasingly needs them to assume a major role in direct patient care and to accept responsibility for drug therapy management and optimizing patient outcomes.

These grants made an additional 10 residency positions available to highly qualified individuals who would have otherwise not had an opportunity for a residency training experience. Leaders at the grant recipient organizations are committed to sustaining these new or expanded programs into the future, thereby reducing the gap in available residency program positions.

## Optimizing Antithrombotic Management: An Assessment Tool for Hospitals and Health Systems

*Developed with support from Sanofi*

In 2015, almost 1,700 pharmacists made use of this web-based assessment tool, which the ASHP Foundation developed for organizations to:

- assess readiness for establishment of new antithrombotic therapy programs.
- plan for optimization of existing antithrombotic therapy services.
- evaluate the outcomes, including overall economic outcomes, of these services.

The Foundation enlists the help of Anne W. Rose, a clinical pharmacist at UW Health in Madison, Wisconsin, to update the information quarterly and create additional resources. Dr. Rose led an interprofessional team in creating an anticoagulation stewardship program that earned UW Health the 2011 Award for Excellence in Medication-Use Safety.

## Practice Advancement Initiative

In 2015, the ASHP Foundation continued its work to support ASHP in advancing patient care in hospitals and health systems through the Practice Advancement Initiative (PAI). Most notable were the following:

### Ambulatory Care Webinar Series:

The Foundation collaborated with the ASHP Section of Ambulatory Care Practitioners to offer the *Ambulatory Care Webinar Series: Lessons Learned From the Front Lines*, which was developed to advance practice consistent with the recommendations from the 2014 Ambulatory Care Conference and Summit, sponsored by ASHP and the ASHP Foundation. Close to 1,500 pharmacists attended the series, which consisted of four webinars. This webinar series was supported by a development grant from the McKesson Corporation.

### **Drug Therapy Management**

**Complexity Score:** Progress on the major research grant contract to the University of Florida to develop this tool was measured through the convening of an advisory committee meeting in March with the research team. The research team developed and tested algorithms for 20 preventable adverse drug events (pADEs). Data elements associated with risk factors for these pADEs were identified, validated and extracted from the electronic health record. The team is in the process of developing a complexity score tool for these pADEs. Research will be completed in 2016.

### Practice Advancement Demonstration Grants:

Two grantees under this program, which supports demonstration projects related to the PAI, were selected and given \$75,000 each in funding. This is the largest practice-based research grant given by the ASHP Foundation, which highlights our commitment to advancing practice.

### PAI State Affiliate Workshops and Toolkit:

Supported by the Henri R. Manasse Legacy Fund, ASHP and the ASHP Foundation offer structured leadership workshops to engage ASHP state affiliates in working to advance patient care and pharmacy practice transformation at the state and local levels. [Four workshops were held in 2015.](#)

## Outsourcing Sterile Products Preparation: Contractor Assessment Tool

Preparation of sterile parenteral products is a critical component of health-system pharmacy practice. Many hospital pharmacy departments in the United States contract with external organizations for the sterile preparation of parenteral medications, which presents significant safety and quality implications that impact not only pharmacists, but physicians, nurses and patients.

The tool helped them evaluate proposals from external organizations that provide parenteral product preparation services. In fall 2014, ASHP completed work to update this tool in view of new guidelines provided by the FDA. The Foundation has updated the tool in tandem with ASHP's efforts to update its *Guidelines on Evaluating and Using Home or Alternate-Site Infusion Providers*. It is now completely electronic and allows users to save multiple assessments within their

account, giving them the option to complete any assessment in one sitting or to return later to complete it. In 2015, the PDF version of this



tool was accessed by 1,898 pharmacists and the web-based tool, which was launched in October, had 500 visitors.

Users complete a series of questions to evaluate proposals submitted by potential outsourcing contractors in the following areas:

- Regulatory compliance
- Quality and patient safety measures
- Medication administration safety features
- Service excellence.

Weighted scores are associated with each response, and upon completion, the tool will generate a report that provides comparative data for all RFP responses. This report can then be used, in conjunction with site visits, to evaluate proposals in the context of the hospital's or health system's patient care and operational needs. 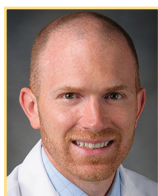

## Research Boot Camp

The Research Boot Camp is a research skills development program comprising distance education, onsite training and research conduct components. The program aims to foster the development of pharmacists with practice-based research skills; to drive the advancement of translational research by providing clinicians with the expertise, tools and support to start a practice-based research program and answer practice-based research questions; and to enhance safe and effective medication use by promoting evidence-based decision-making for individual patients and populations of patients.

## Pain and Palliative Care Traineeship

The ASHP Foundation's Pain Management and Palliative Care Traineeship is a 5-month program that prepares participants to design patient-specific pharmacotherapy; solve drug therapy problems; and develop protocols, policies and procedures for patients requiring pain management or palliative care needs.

The program is a tiered educational initiative consisting of a combination of distance education, including self-study and interactive web-based presentations with discussion and onsite experiential training.

The distance education curriculum includes two components: *Principles of Pain and Pain Management* and *Advanced Pain Topics*. The first component, *Principles of Pain and Pain Management*, was released in the fall of 2015, and more than 240 pharmacists participated.

## IN MEMORY

### TOBY CLARK



The pharmacy world and the ASHP Foundation lost a friend and a passionate leader when Toby Clark passed suddenly on October 18, 2015. Toby's support of the ASHP Foundation dates back to the early 1980s, and he

was a consistent and generous donor of his time, expertise and financial resources.

Chuck King, the ASHP Foundation's CEO from 1986–2000 reflected on his friend and colleague as follows: "Toby was always involved in working to help patients, pharmacists, pharmacy departments, hospitals, health systems and pharmacy organizations do their very best in providing outstanding care to patients. He was invariably helping, teaching, advising and assisting people to improve themselves and what they do."

Stephen Allen, the Foundation's current CEO, recalls that "Toby was one of the first to make an appointment with me when I came to the Foundation in 2000. He offered program concepts, assisted in raising funds and was one of the first to recommend expansion of the Foundation's leadership programming commitments. 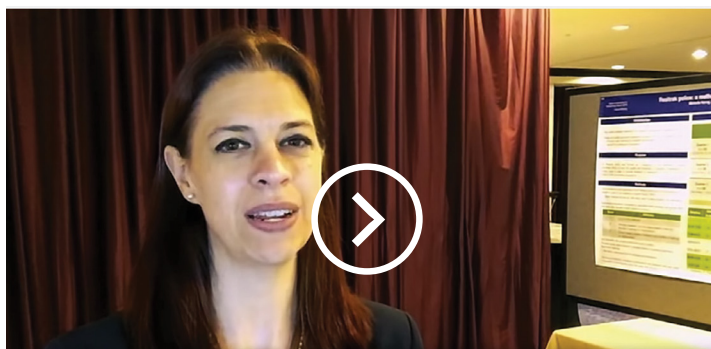

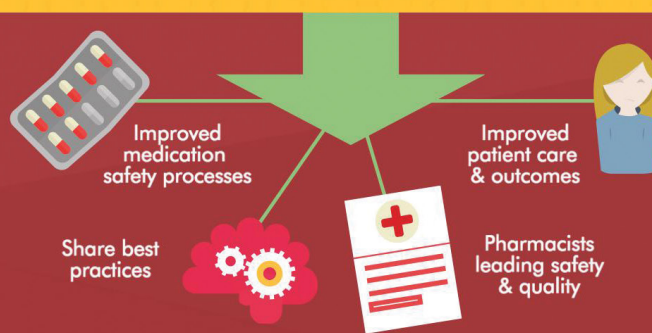
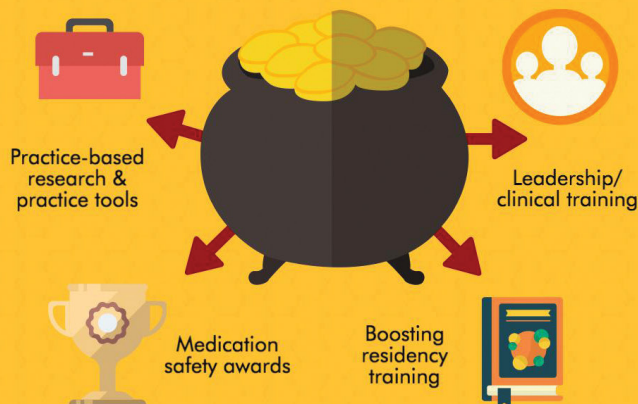
